

Member Fee Schedule

This fee schedule is exclusive to services provided by dental offices participating in **Smile Saver Dental Plan** (“Plan”). “Member Savings” is defined as the percentage discount on a participating office’s usual and customary fees normally charged to uninsured, self-pay patients. Unless otherwise specified in this fee schedule, plan discounts do not apply to services performed by a dental specialist (i.e., periodontics, endodontics, orthodontics, and oral surgery) or dental hygiene products (e.g., chlorhexidine, toothbrushes, etc.). Member savings and plan incentives are exclusive to participating dental offices. Exact member savings and availability of certain procedures may vary by location. *Free exams limited to 2x per member/per annual membership term.*
